

The 13th edition of the World Exchange Congress began at the Shangri-La Barr al Jissah Resort & Spa on Tuesday with participation of over 250 experts, specialists and financial decision maker from 60 countries. The World Exchange Congress is unofficially the biggest annual meeting for CEOs and senior executives of the world's trading venues.



The opening ceremony was held under the patronage of Dr Ali bin Masoud al Sunaidy, Minister of Commerce and Industry. The two-day conference was organised by Terrappin in cooperation with the Muscat Securities Market (MSM).
