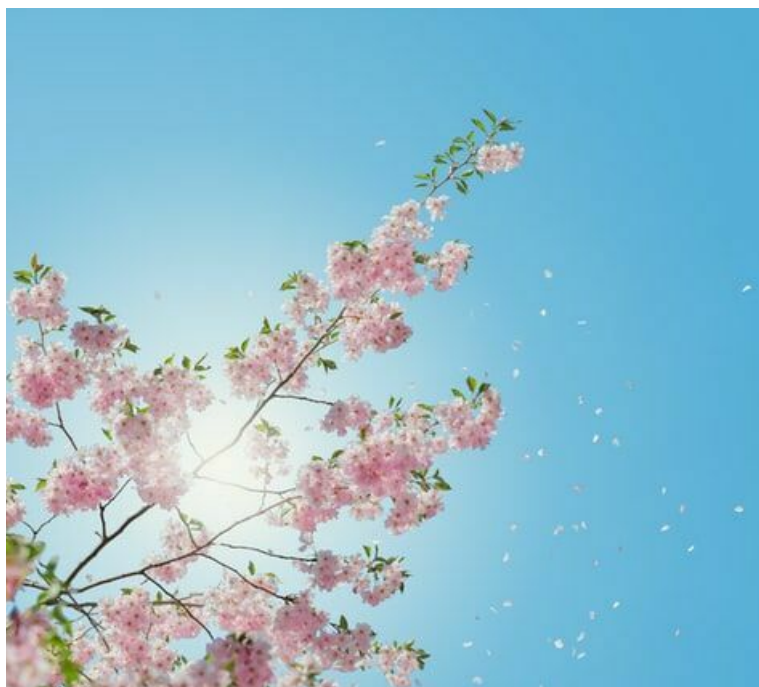

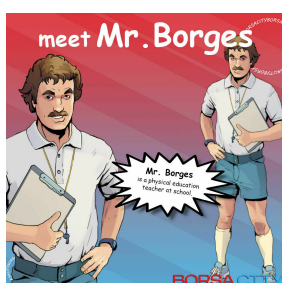
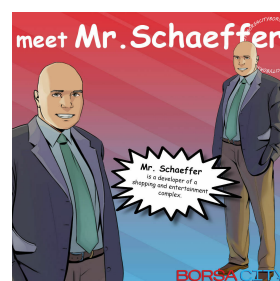

On March 9th, 2022, The Federation of Euro-Asian Stock Exchanges (FEAS), alongside with its members Muscat Stock Exchange and Muscat Clearing & Depository, held the

“Meet the Market with FEAS | The Omani Capital Market” virtual event. This event was the eight one in the Meet the Market with FEAS event series, and the first one in the year 2022. The purpose of the initiative is to organize virtual Meetings/ Roadshows for FEAS members’ markets to raise awareness about the market structures, operations, processes and benefits, and give the answer to the question “Why to invest in a specific country”?

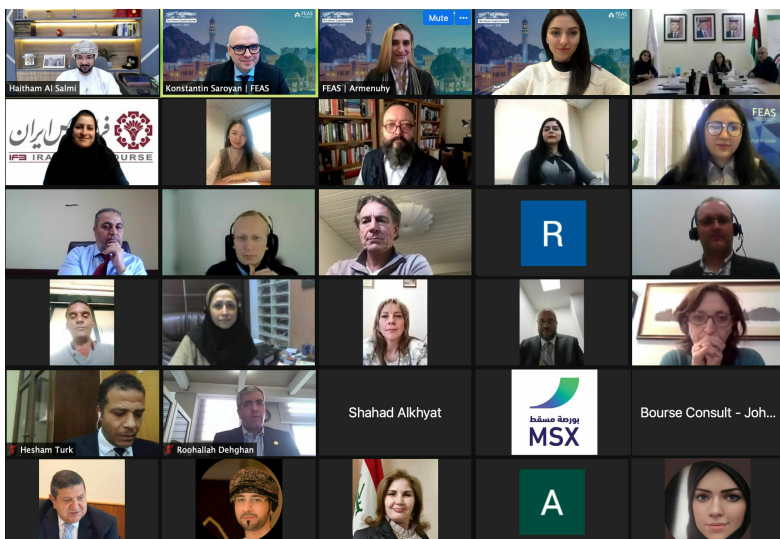
Muscat Stock Exchange, Muscat Clearing & Depository

Mr. Haitham Al Salmi, CEO of Muscat Stock Exchange and Chairman of Muscat Clearing & Depository presented the Omani Capital Market and answered the participants' questions. He presented during his presentation a brief history of Muscat stock market (MSX) from 1971 to 2021, capital market sector and he briefed the audience about the Exchange's instruments. He highlighted MSX Performance in five years and talked about the market cap & the turnover for the year 2021. Further, Mr. Haitham spoke about the investors trading which includes the value of shares bought / sold by Omani investors and Non-Omani investors. He also talked about MSX companies financial performance 2021 compared to 2020 as well as the ESG, which stands for environmental, social, and governance. He stated that Investors are increasingly applying these non-financial factors as part of their analysis process to identify material risks and growth opportunities. Finally, Mr. Haitham spoke about MSX access and future plans.

Dr. Konstantin Saroyan, FEAS Secretary General said: "I would like to thank Mr. Haitham Al Salmi for introducing us to the Omani Capital Market in such an engaging way.

This is the eight time we are meeting to discover FEAS Members Markets, and I am glad that even in these uncertain times, we, together with our members, stand for our mission to promote and develop the cooperation and collaboration of capital markets. 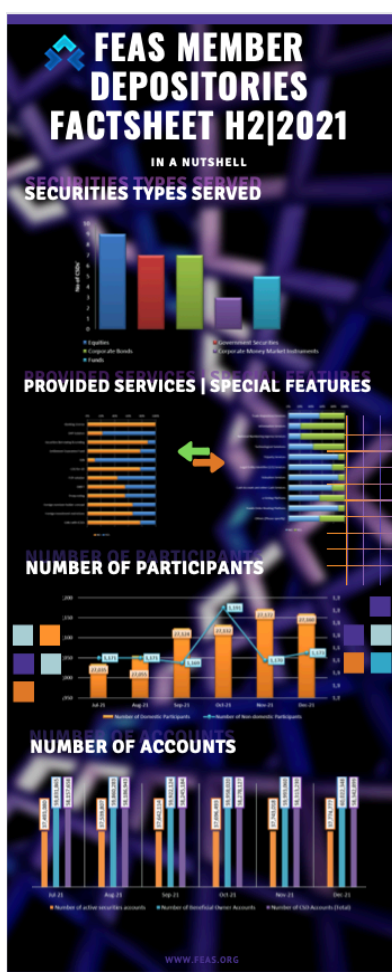
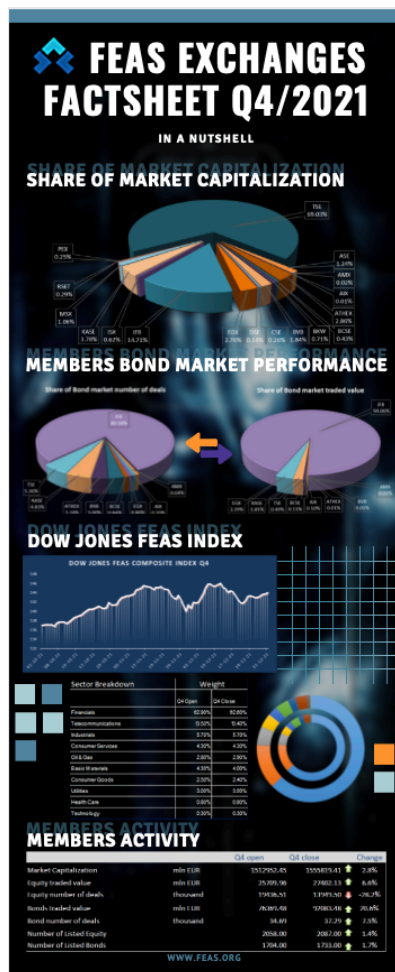


Visit to Muscat

Congratulations #FEASMember KaseStock Exchange for winning the Best Stock Exchange Central Asia 2022 nomination according to the CFIA Awards 2022 International award.

CFIA expert commission noted the positive dynamics of the main indicators of the Exchange. In particular, the growth in trading volume by 43% in 2021, the market capitalization of which is \$6.6 billion. The main indicators of the money market growth \$55 billion were noted. The emphasis was also placed on achievements in the field of ESG and the issuance of green bonds.

CFIA deserves special credit for its progress in ESG funding. The exchange joined the UN Sustainable Exchange Initiative (SEI) in 2015, updated its ESG methodology with IFC in 2018, and introduced the best conditions for the placement of Asian Development Bank ESG bonds in 2020 year – according to the expert opinion of the Jury of Capital Finance International.

CFIA Awards was established by the British edition of Capital Finance International, which presents news in the field of finance, economics and business.
