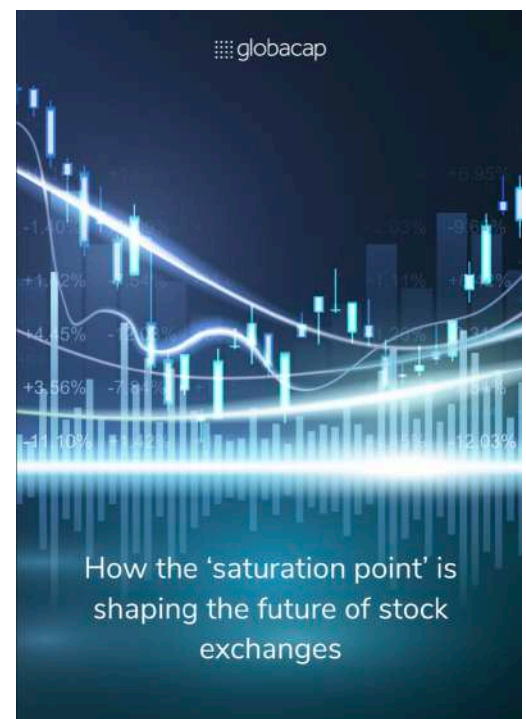


THE "SATURATION POINT": HOW ARE STOCK EXCHANGES ADAPTING?
